## **Investigating Committee**

The Investigating Committee handled 6 new cases from various agencies during the month of March. Two cribs and mattresses were delivered to the case worker from Chautauqua Opportunities for unwed mothers living solely on public assistance. Another crib and mattress was given to the CPS/Preventive Unit for a mother with 3 children. Recently homeless, she had just secured housing and was looking to "house" her newborn in a crib. The case workers expressed deep gratitude and appreciation for all that the members of Crèche do to create a safer environment for children.

Two sets of sheets and blankets were pulled from inventory for an unwed mother with four children who lives on a monthly income of just \$130. The PACERS representative told me that the mother was VERY thankful. Another case involved a 5th grade boy who had scoliosis surgery in Philadelphia. The mother needed gas money to help pay fuel expenses. A \$50 Kwik Fill Gas Card was purchased and mailed to her advocate, a past social worker at WCA. Our third request was for clothing for the children (ages 9, 3 and one month) of an unemployed, single mother of three. Clothes were pulled from inventory and given to the two youngest children. Clothing was purchased at Ebe's for the oldest boy as there were no sizes for him available in our inventory.

Our Committee would like to thank our members for **ALL** their contributions to Crèche. Without your monetary gifts and donations, the Investigating Committee could not successfully function!

The Sewing Committee also plans to have limited events during the 2014 Lenten season for those who still enjoy the social part of sewing.

Special thanks to associate members Cheryl Johnson, Deb Johnston and Brenda Schultz for attending sewing this year. Cheryl was at sewing almost as much as Katryn. As always, a huge thank you to Betsy Dalton who sews all of our infant gowns each year. Betsy's work amounted to more than 36 hours of sewing this season. Thanks also to Michele Hartweg who brought her daughter, Mekenna, who plans a career in fashion design. A special thank you to Committee member, Karen Dennerlein, who sewed for two all-day sessions. Karen even brought a non-member friend who sewed all day at our final meeting.



Thanks to all who came to sew, cut, pin or took items home to complete. We couldn't do this without you.
